


































































GENERAL ARRANGEMENT





SUMMARY

SKYFALL standing for a 68.15 m luxury motor yacht currently under construction at the Sunrise Yachts shipyard in Turkey. She has the finest balance between elegance and strength, beauty and space. Her exterior was designed by Andrea Vallicelli and interior was designed by Focus Yacht Design. Her naval architects from Mulder Design worked with engineers from Unique Yacht Design to provide best performance of superyacht. Moreover, SKYFALL 68.15 m boasts with 1320 grt being the largest yacht of the yard built today.

Sunrise SKYFALL superyacht will spread over 4 spacious decks and feature ample space for leisure and relaxing on her exterior decks. With final layouts to be decided by the future owner the developed drawings include a large sundeck with jacuzzi, sunbathing area, bar and alfresco dining area. Forward on the upper deck is a terrace dedicated for the owner having an own direct access to the helipad. The main deck of SKYFALL will feature another area dedicated for relaxing and sunbathing and features an open-air lounge and swimming pool.

The most distinguish feature of the biggest Sunrise motor yacht is her expansive beach area at water level. It can be easily transformed into an ultimate spot for relaxing putting pleasure to the fore, with large hull-openings allowing natural light to illuminate the fitness and wellness area, which includes a gym, massage room and sauna. A large lounge is perfect to enjoy spectacular views on sea level and completes the massive beach club design of this stunning super yacht.

The aesthetics of the design is completed by unique features, such as the walk-around platforms around the transom of the yacht, connecting the full beam open garage, beach area, and fitness club.
